2. Main Purposes and Distinctive Features of the Programme

The BTEC Level 4 Higher National Certificate in Animal Management offers students a broad introduction to the subject area via selected compulsory core learning modules, while allowing an achievement of skills and experience to be obtained through a variety of both specialist and optional units. These units consist of subjects that cover a range of work-related sectors at Level 4. This fundamentally builds skills while preparing the student for progression onto Level 5 or employment. Knowledge will be achieved which is fundamentally tied to practical skills, related to the work sector, which are gained in research, directed study and workplace scenarios.

The BTEC Level 5 Higher National Diploma will allow students to develop a thorough understanding of the principals involved within animal management, learning how to apply these principles widely within the subject areas. Being able to perform successfully in their chosen field and having the traits necessary for employment, for example, practicing personal responsibility and decision-making, are skills within which students, upon completion of the programme, will be able to achieve.

3. Admissions Criteria

City and Guilds Level 3 Advanced Technical Diploma 1080 (MPP) and the City and Guilds Level 3 Advanced Technical Diploma 720 (MM).

Mature students will be assessed on individual merit, work experience and suitability for the programme.

• English language requirements: Common European Framework of Reference (CEFR) level B2; or • Pearson Test of English Academic (PTE Academic) 42; or • Pearson Test of English General (PTE) Level 3; or • Pearson Versant English Test 58-68; or • International English Language Testing System (IELTS) 5.5; with both Reading and Writing elements at 5.5.

Claims for Recognition of Prior Learning (RPL) and Recognition of Prior Experiential Learning (RPEL) are welcomed by the Programme team.

The College welcomes applications from candidates who do not meet the above criteria. Where this is the case, applicants will be invited for interview at which they will be expected to provide a portfolio (either physical or digital) that demonstrates professional industry experience in a relevant discipline and/or can demonstrate a strong interest in this through extra-curricular activity, research or work experience. As part of the interview process, candidates may be evaluated for their aptitude to study at this level

4. Progression Opportunities





On successful completion of the level 4 qualification (HNC in Animal Management), the programme will provide opportunities for students to progress to the Higher National Diploma in Animal Management (Level 5). The HNC provides a solid base in animal management, from which students can develop and continue their studies beyond the certificate stage to the diploma. The level 4 essentially builds a foundation of core skills allowing the student to gain preparation for potential progression onto Level 5 (HND). The HNC course will broaden the students access to higher education and/or enhance the career possibilities of those who undertake the course.

Upon successful completion of the HND students can progress onto further study in higher education, undertaking a top up degree. HND students will have established a thorough understanding of the principles in animal management and will have learnt how to apply those principles further. The HND is accepted by Higher Education providers as meeting entry requirements to various relevant animal management related courses such as animal behaviour, animal management and animal welfare. Alternatively, upon completion of the HND students can also progress directly into employment in fields such as animal behaviour and welfare (animal keeper/animal trainer) or animal science (animal instructor/veterinary assistant).

7. Teaching, Learning & Assessment Strategies

Teaching and learning methods are aligned to the learning outcomes and support learners in becoming independent enquirers, problem solvers and effective communicators. The HE lecturers will engage students in a range of pedagogy approaches that ensure links are made between theory and practice. Staff will ensure an active engagement with research informed teaching, where tutors will exchange knowledge with students to build an active community of learners, which will inspire and empower students to contribute and achieve. Examples include:

- Lectures
- Seminars
- Practical's
- Guided independent study
- Blended learning (including TEAMS)

- Guest lectures
- Small group learning
- Role play
- Case study analysis

Knowledge and understanding will be assessed through:

- Written reports and/or essays
- Practical assessment
- Presentations
- Laboratory reports
- Research projects
- Observations
- Reflective accounts
- Work Placement/Voluntary work (if applicable)
- Trips/visits (subject to availability and additional costs will be incurred, these are not included in course fees)

Prior to formal assessment students will have taken part in a range of activities that support their preparation for final assessment that allow students to critically consider their application of theory to practice. There will be a balance between formative (developmental) feedback and summative (judgmental) feedback to promote deeper learning among students and to give students an opportunity to maximise their potential. The assessment of the BTEC Higher National qualifications is criterion-based and learner's evidence is assessed against the learning outcomes. The purpose of this is to ensure effective learning of the content of each unit has taken place. All units are individually graded as PASS, MERIT or DISTINCTION. However, the focus is on the overall learning outcome for individual assessments. Should you fail to meet the requirements of the learning outcomes you could fail the unit/programme. Those programmes with a work placement requirement will have to gather extensive evidence of these hours and the knowledge application, skills and behaviours necessary for the award.

During the HND students will need to undertake **80** hours of work experience as a minimum to pass the course. This can be within the field of animal management (preferred) however we do understand if this is not always possible and will discuss optional work sectors that this can be completed within. It will be expected that students negotiate and agree work experience in an appropriate work context independently, which then has to be discussed and approved by the employer and unit tutor.

8. Study Support

Student's primary source of support is through the Curriculum Leader and individual unit tutors. The College also provides a range of support and advice services that can be accessed through the student service team, including signposting to mental health services and UCAS applications for progressing students. All learners are supported on an individual basis in order to ensure all students have equal access to the learning opportunities on offer and ensure fair assessment, adjustments may be made to the programme, teaching styles and assessment practices.
